According to Finance Act, 2013, Amendment of Ordinance XLIX of 2001. In the Income Tax Ordinance, 2001 (XLIX of 2001), 236I. Collection of advance tax by educational institutions.- (1) There shall be collected advance tax at the rate specified in Division XVI of Part-IV of the First Schedule on the amount of fee paid to an educational institution. Advance Income Tax @5% Rs. 28, 505/-
